#### **Record Identifiers**

The data relationships are indicated in the symbolic indentations below. In summary, the RO.HEADER "owns" all work on the RO. The RO.CUSTOMER record "owns" all work following it until either an RO.CLAIM or RO.INTERNAL record is encountered. Similarly, once either an RO.CLAIM or RO.INTERNAL record is encountered. Each of these 4 record types now has a "Data Collection Status" flag, indicating the status of that collection of work. This will lead to a single customer status, a status for each claim, a status for each internal group, and an overall status for the RO. Although claim (Warranty) work was originally identified as a full set of work that is either complete or not, having each separate claim status' allows further status detail. Also, this structure provides that there may be (although maybe not at present) multiple sets of internal-pay work. The RO.JOBREFERBACK record is used when (as requested) a job needs to be referred to on more than one claim. The RO.JOB collection referred to by an RO.JOBREFERBACK record must already exist within the context of the logic presented. In other words, if an RO.CLAIM contains a RO.JOBREFERBACK, the referenced RO.JOB record must already (sequentially) exist under some other claim.
